District Plan: Meal Charge and Prohibition Against Meal Shaming

I. Purpose

The goal of the Chautauqua Lake CSD is to provide student access to nutritious no- or low-cost meals each school day and to ensure that a pupil whose parent/guardian has unpaid school meal fees is not shamed or treated differently than a pupil whose parent/guardian does not have unpaid meal fees.

Unpaid charges place a large financial burden on our school. The purpose of this policy is to insure compliance with federal requirements for the USDA Child Nutrition Program and to provide oversight and accountability for the collection of outstanding student meal balances to ensure that the student is not stigmatized, distressed or embarrassed.

The intent of this policy is to establish procedures to address unpaid meal charges throughout the Chautauqua Lake CSD in a way that does not stigmatize, distress or embarrass students. The provisions of this policy pertain to regular priced reimbursable school breakfast, lunch and snack meals only. The Chautauqua Lake CSD provides this policy as a courtesy to those students in the event that they forget or lose their money. Charging of items outside of the reimbursable meals (a la carte items, adult meals, etc.) is expressly prohibited.

II. Policy

Free Meal Benefit – Free-eligible students will be allowed to receive a free breakfast and lunch meal of their choice each day. The meals offered to students will be reimbursable meals available to all students. A la carte items or other similar items must be paid/prepaid.

Reduced Meal Benefit – Reduced-eligible students will be allowed to receive a breakfast of their choice for \$0 and lunch of their choice for \$0 each day. The meals offered to students will be reimbursable meals available to all students. A la carte items or other similar items must be paid/prepaid.

Full Pay Students - Students will pay for meals at the school's published paid meal rate each day. The meals offered to students will be reimbursable meals available to all students, unless the student's parent or guardian has specifically provided written permission to the school to withhold a meal. A la carte items or other similar items must be paid/prepaid.

ONGOING ELIGIBILITY CERTIFICATION:

School staff will conduct direct certification with the New York State Student Identification System (NYSSIS) or using the New York State Education Department (NYSED) Roster Upload to maximize free eligibility. NYSED provides updated direct certification data monthly.
School staff will provide parents/guardians with free and reduced price application and instructions at the beginning of each school year in school enrollment packet.
Should the school offer an electronic meal application, the district will provide an explanation of the process in the school enrollment packet and instructions on how to request a paper application at no cost.
The school will provide at least two additional free and reduced price applications throughout the school year to families identified as owing meal charges.
The school will use administrative prerogative judiciously, only after using exhaustive efforts to obtain a completed application from the parent/guardian only with available information on family size and income that falls within approvable guidelines.
The school will coordinate with the foster, homeless, migrant, runaway coordinators to certify eligible students. School liaisons required for homeless, foster, and migrant students shall coordinate with the nutrition department to make sure such students receive free school meals, in accordance with federal law.

Students/Parents/Guardians may pay for meals in advance via www.MySchoolBucks.com or with cash or a check payable to CLCS School Lunch. Further details are available on the Cafeteria pages at www.clake.org. Funds should be maintained in accounts to minimize the possibility that a child may be without meal money on any given day. Any remaining funds for a particular student may/will be carried over to the next school year.

Refunds for withdrawn or graduating students: A written or e-mailed request for a refund of any money remaining in their account must be submitted. Students who are graduating at the end of the year will be given the option to transfer to a sibling's account upon receipt of a written request.

Unclaimed funds must be requested within one school year. Unclaimed funds will then become the property of the Chautauqua Lake CSD Food Service Program.
