Dear Chautauqua Lake Central District Community:

The health and safety of our students and staff is our top priority. With that in mind, the purpose of this letter is to inform you that we had eight individuals over this past week and the two weeks over Spring Recess who have tested positive for COVID-19.

We have been working directly with the Chautauqua County Department of Health ("CCDOH") and are taking all recommended steps to ensure the safety of our students and staff. These individuals and the close contacts will not return to our campus until they have completed quarantine/isolation procedures for COVID-19 as directed by the CCDOH. If you are not contacted by the Department of Health or the Chautauqua Lake Leadership Team, you can assume that your child was determined not to have been in close contact. Only those individuals who have had close contact with the individuals who tested positive will be contacted by the CCDOH or the Chautauqua Lake Leadership Team.

We will continue to follow all Department of Health protocols and provide further updates if additional steps need to be taken by our program. We ask that you please continue to monitor for COVID-19 symptoms and keep your child home if they are sick. In addition, please contact your healthcare provider or our school nurses (753-5819) if you develop symptoms or if you have any additional questions or concerns.
