Every second and fourth Wednesday of the month, the members of the Board of Education meet to discuss the decisions that govern the education of our children. Beginning from the early stages, our families have the Chautauqua Lake Child Care Center, to the later stages of education, our students are able to access Jamestown Community College or the Rochester Institute of Technology, to support the educational pathways of their choice. Our students have choices to participate in our Project Lead the Way program, Manufacturing / STEM program, or our New Visions program. Our choices for the budget have considered the future effects of the COVID-19 pandemic, our student's upcoming needs, and our community's needs as we make budgetary decisions.

We continue to partner with Ripley Central School District and feel that our tuition agreement continues to offer advantages to all students. The budget for the 2022-2023 school year represents the lowest tax levy increase over the last five years, at .38%. We enjoy having members of the community attend our bi-monthly meetings and look forward to your future involvement. PROPOSITIONS FOR VOTE

Key Aspects of 2022-23 Chautauqua Lake Budget Propositions

Proposition 1 – Budget: A **0.38%** tax levy increase, the lowest annual increase in the tax levy in the past 5 years.

Proposition 2 - Capital Reserve: This capital reserve will enable the district to allocate funds to address future capital improvement projects that are not fully funded in the district's annual operating budget.

Proposition 3 – Repair Reserve: This reserve will enable the district to address public safety concerns on campus by allocating funds for unexpected facility repairs, equipment failure, and infrastructure replacement.

PROPOSITION NO. 1 - BUDGET

RESOLVED, that the budget for the Chautauqua Lake Central School District, Chautauqua County, New York, for the fiscal year commencing July 1, 2022 and ending June 30, 2023 as presented by the Board of Education is hereby approved and adopted in the amount of \$23,585,665 and the required funds therefore are hereby appropriated and the necessary real property taxes required shall be raised by a tax on the taxable property in said District to be levied and collected as required by law.

PROPOSITION NO. 2 – GENERAL CAPITAL RESERVE FUND

RESOLVED, that the Board of Education of the Chautauqua Lake Central School District (the "School District") is hereby authorized and directed to:

(A) establish a reserve fund pursuant to Education Law Section 3651 to be known as the "General Capital Reserve Fund-2022," for the purpose of financing, in whole or in part, additions, alterations, renovations or other improvements to existing School District's buildings and facilities, the construction of new buildings or facilities or the acquisition of lands or interests in lands for School District purposes, including the acquisition and installation of machinery, equipment, apparatus or furnishings required for the purposes of such buildings and facilities, and playgrounds, athletic fields, recreation areas, parking areas, roadways, sidewalks and other site improvements connected to such buildings and facilities, with the ultimate amount of such reserve fund not exceeding Seven Million Dollars (\$7,000,000) plus any accrued earnings on amounts deposited in such reserve fund, the probable existence of said reserve fund being ten (10) years, but said reserve fund to continue in existence for its stated purpose until liquidated in accordance with Education Law, and the source from which funds shall be obtained for said reserve fund being (i) current and future unappropriated fund balances from the existing General Capital Reserve Fund of the School District, as directed by the Board of Education and (ii) any other appropriations authorized by the voters from time to time; and

(B) transfer to said capital reserve fund the entire balance on deposit in said School District's existing General Capital Reserve Fund established pursuant to Education Law Section 3651 pursuant to a proposition approved by the qualified voters of said District on June 19, 1996.

PROPOSITION NO. 3 – REPAIR RESERVE FUND

RESOLVED, that the Board of Education of the Chautauqua Lake Central School District (the "District") is hereby authorized and directed to transfer unassigned general fund balance at the conclusion of the 2021-2022 fiscal year ending June 30, 2022, in the maximum amount of \$750,000, or so much thereof as is available for this purpose, into the School District's Repair Reserve Fund (established on March 23, 2022); and be further authorized to deposit, invest and account for such funds strictly in accordance with General Municipal Law §6-d.


 Estimated Basic STAR Exemption Savings¹

The annual budget vote for the fiscal year 2022-23 by the qualified voters of the Chautauqua Lake Central School District, Chautauqua County, New York, will be held at Chautauqua Lake Central School in said district on Tuesday, May 17, 2022, between the hours of 7 a.m. and 8 p.m., prevailing time in the Chautauqua Lake Central School, at which time the polls will be opened to vote by voting ballot or machine.

SUMMARY OF ANTICIPATED REVENUES 2022-23



o meet the **Proposed Operating Budget** of \$23,585,665 the district has projected the following anticipated revenues:

State Aid includes Basic Operating Aid as well as a number of categorical aids, including BOCES Aid, Transportation Aid, Excess Cost Aid, Textbook, Building and Miscellaneous Aids.

Other Revenues include Charges for Services, Tuition, Student Fees, Interest Earnings, Sale of Excess Property and Equipment, Prior Year Refunds, and Interfund Revenues.

Local Tax includes Real Property Tax Payments in Lieu of Taxes, and Interest/Penalties on delinquent tax payments.

SUMMARY OF ANTICIPATED EXPENSES 2022-23

The Administrative component includes office and central administrative expenses, travel expenses, salaries and benefits for all certified school administrators and supervisors who spend a majority of their time performing administrative or supervisory duties.


Also included are expenditures associated with the operation of the Board of Education, Superintendent's Office, general administration, the school business office, any consulting costs not directly related to district services or programs, and all other administrative activities.

The **Capital** component includes debt service payments and maintenance costs, and BOCES capital/rent costs.

The **Program** component of the budget includes the salaries and benefits of teachers and any school administrators and supervisors who spend a majority of their time performing teaching duties. All transportation operating expenses are included, as well as all instructional costs, such as textbooks, classroom supplies, field trips, instructional equipment, student support services, extracurricular and interscholastic sports programs.

UNDERSTANDING YOUR SCHOOL TAXES

These Three Numbers Affect Your Tax Rate:

- 1. The Tax Levy from the school district
 - From the budget approved by district voters
 - The greater the levy, the higher the tax rate
 - Set by district voters at the May Budget Vote
- 2. The Equalization Rate set by New York State
 - Brings the assessed value up to full value if no re-evaluation has been done by the township
 - The lower the equalization rate, the higher the full value and your tax rate
 - Fixed in August by New York State Property Tax Division
- 3. The Total Assessed Value of the District set by the tax assessors of the towns
 - From home improvements, new construction, etc.
 - The more improvements, the higher the assessed value and the lower the tax rate
 - As set by town assessors in June

Fiscal Responsibility with Program in Mind

The proposed 2022-23 budget was formulated over many months to take into consideration the various elements of school programming, while keeping the taxpayer in mind. For the tenth year in a row following the enactment of the tax cap law, the proposed budget does not exceed the Maximum Allowable Tax Levy. In fact, this budget results in a tax increase of less than the maximum allowable amount. This budget provides the resources to preserve and enhance the programs and services at the center of the district's mission. While the increase in spending is less than two percent, we continue to keep our commitment to maintain a quality facility that houses robust educational opportunities for our students. This budget is designed, among other things, to:

- Offer a vibrant elementary school experience that provides learning support as well as enrichment opportunities.
- Provide unique secondary school offerings including television production, Project Lead the Way (pre-engineering), rigorous manufacturing courses and numerous college credit-bearing choices.
- Meet all state and federal mandates.
- Support building and facility improvements as guided by the district's rolling five-year plan.
- Keep our students and staff as safe and healthy as possible.
- Provide co-curricular and athletic options that align with our goals and priorities.

Understanding the Calculation: Tax Levy Limit and Maximum Allowable Tax Levy

The Calculation of the "Tax Levy Limit" and "Maximum Allowable Tax Levy" worksheet above has been used in developing the proposed 2022-23 School Budget. The calculated \$12,543,487 "Maximum Allowable Tax Levy" is a \$78,743 (or 0.40%) increase over the 2021-22 tax levy of \$12,493,744. (Note: The Board's proposed budget is below the maximum allowable tax levy at \$12,541,220.)

Additionally, tax rates paid by individual taxpayers may differ greatly from one household to another, based on such factors as equalization rates and updated assessments.



PROCEDURES FOR ABSENTEE BALLOTS

The Board of Education authorizes the District Clerk (or board designee) to provide absentee ballots to qualified district voters. Absentee ballots may be used for the election of school board members and for adoption of the annual budget and referenda.

A district voter must request in advance an application for an absentee ballot. The voter must complete the application and state the reason he/she will not be able to appear in person on the date of the district election. The application must be received by the District Clerk at least seven days before the election if the ballot is to be mailed to the voter, or the day before the election if the voter will be picking up the ballot in person. Pursuant to the provisions of Education Law, a district voter may vote by absentee ballot if during all the hours of voting on the day of an election he or she will be:

- 1. absent from the county of his or her residence; or
- 2. unable to appear at the polling place because of illness or physical disability, or duties related to the primary care of one or more individuals who are ill or physically disabled, or because he or she will be or is a patient in a hospital, provided that, for purposes of this subparagraph, "illness" shall include, but not be limited to, instances where a voter is unable to appear personally at the polling place of the school district in which they are a qualified voter because there is a risk of contracting or spreading a disease that may cause illness to the voter or to other members of the public; or
- an inmate or patient of a veteran's administration hospital; or
- 4. absent from his or her voting residence because he or she is detained in jail awaiting action by a grand jury or awaiting trial, or confined in jail or prison after a conviction for an offense other than a felony, provided that he or she is qualified to vote in the election district of his or her residence.

An absentee ballot must reach the office of the District Clerk no later than 5 p.m. on the day of the election. A list of all persons to whom absentee ballots have been issued shall be maintained by the District Clerk and made available for public inspection. Any qualified voter challenging the acceptance of an absentee ballot must file a written statement with the District Clerk or inform the election inspectors on the day of the district election. Any district resident who needs an absentee ballot and is qualified to vote in this election should contact the District Clerk's Office, 100 N. Erie Street, Mayville, NY 14757 (716-753-5808) to request an application.

OPTICAL SCAN VOTING MACHINES

District voters will again use optical scanning machines when they vote on Tuesday, May 17. The machines are also in use in Chautauqua County for other elections. Poll workers will be available to assist anyone unfamiliar with this voting method. Each voter must affirm legal residency within the Chautauqua Lake Central School District. Photo identification is preferred.

If you would, please share why you are running for the school board? If elected, what will be your top five priorities and why?

Additionally, it promotes shared services with neighboring districts (Project Lead The Way, Manufacturing Program), offers a variety of college level courses with 78 potential college credits, and community service projects at all grade levels. These elements are what makes Chautaugua Lake Central School a GREAT district.



As a prospective school board member, what are your views on promoting progressive curriculum, programming, and extracurricular activities for our students?

Declining enrollment continues throughout Chautauqua County schools, indicating a need for shared services with neighboring districts. Shared services assist our district in providing quality education and diverse opportunities while being fiscally responsible to our taxpayers. Chautaugua Lake Central School is currently sharing services with Ripley, Westfield, Brocton, and JCC. Programming and experiences created with collaboration of other districts include sporting teams, tuitioning of Ripley students, Project Lead the Way (RIT), Manufacturing Program (JCC), and cultural enrichment through Chautaugua Institution. In order to sustain these varied opportunities for our students, we will need to continue collaborating with our neighboring districts. Our district should continue being proactive in identifying opportunities for shared services.

What particular experiences or skills qualify you to serve as a school board member?

As a Physical Therapist in home health care, I collaborate daily with other professionals and clients to identify goals, barriers, and creative solutions. Client's needs are ever changing. What was beneficial in the past may no longer be the solution. My experience as a school board member has shown me this is also true in education. I will use my professional experience to collaborate with team members, think proactively and be open to change. Our goal is to create a strong educational foundation for all students to succeed.

In what school/district activities have you been involved?

As a Board of Education member, I have participated in Negotiations, Budget Task Force, Capital Project Playground Committee, Capital Project Kitchen Committee, Superintendent search and hiring process. BUDGET PROPOSITION: Resolved, that the budget for the Chautauqua Lake Central School District for the fiscal year commencing July 1, 2022 and ending June 30, 2023, as presented by the Board of Education, is hereby approved and adopted in the amount of \$23,585,665 and the required funds therefore are hereby appropriated and the necessary real property taxes required shall be raised by a tax on the taxable property in the said District to be levied and collected as required by law.

Voting for School Board Members: Two "three-year term" board seats will be filled this year. All candidates are running "at large," and the two candidates with the highest number of votes shall be declared elected.

QUALIFICATIONS FOR VOTERS

According to education law, to be qualified to vote in a school district election, a person must be:

- 1. A citizen of the United States
- 2. (At least) Eighteen (18) years of age
- 3. A resident within the school district for a period of at least thirty (30) days next preceding the day of the election*

*A person may have only one legal residence, which is normally determined by a combination of the following:

- 1. The place that he or she votes in a federal, state or local election
- 2. The place where he or she pays income taxes
- 3. The place where his or her automobile is registered

Each voter must affirm legal residency within the Chautauqua Lake Central School District. Photo identification preferred.
