CLCS is holding a district-wide capital project vote on **Tuesday**, **December 15, 2020**.

The capital project vote will take place on Tuesday, December 15, 2020 from 7 AM to 7 PM. In order to adhere to current safety requirements, voting will be held at the district's Bus Garage, where proper social distancing and sanitization procedures will be in place. Alternatively, mail-in absentee ballots may be requested from the district office up until December 8, **2020**. The absentee ballots must be received by the district clerk by 5 PM on the day of the vote. We would like to encourage all of our Chautauqua Lake community members to vote -- either in person or via absentee ballot -- on this important project. ### **Attendance Notice**

It is the responsibility of the staff to teach children, and we are unable to do our job if the student is absent. Although we would never want students to come to school when they are ill, an established pattern of regular attendance early on will last for your child's entire educational career.

The guidance staff meets regularly with principals Megan Lundgren and Rachel Curtin to review student attendance and contact parents with any concerns. Class work can be sent home and completed, but this cannot replace what the child missed hearing directly from teachers or in class discussion.

Parents planning to pick students up before the end of the school day must send a note with the student, requesting early dismissal. The note must be turned in at your child's main office at the start of the school day, so the dismissal time may be noted on the daily attendance report. This allows the student to sign out at the designated time, then leave the building to meet their parent/ guardian.

### **Chautauqua Institution Brings Professional Development Training to CLCS Teachers**



For the fourth consecutive year, Chautauqua Institution is providing professional development opportunities in arts integration strategies for Chautauqua County teachers through the Kennedy Center Partners in Education program. This program is a partnership

between the John F. Kennedy Center for the Performing Arts, Chautauqua Institution, Chautauqua Lake Central Schools, and Jamestown Public Schools.

This year's program has been designed to focus on best practices in online teaching strategies."These workshops are some of the most worthwhile workshops I've ever attended. I always take away a few pieces that I put into practice immediately," said 5<sup>th</sup> grade teacher Shari Tennies.

Teaching artist Sean Layne has already presented two online workshops for his Acting Right programs that focus on teaching behaviors and establishing a collaborative, engaging classroom culture. "Are you the boss of your brain?" asks Mr. Layne. "Is that a strong choice or a weak choice?" A student describing the online session said, "I liked the part where our classmate was making noises, I was going to laugh but I told my brain to stop. I pretended like I was in an iceberg and only my lips could move." Sean Layne responded, "That made your brain strong. You are the boss of your brain." A participating teacher commented, "I was not sure how this would work with a remote class, but Sean's conversation is giving me the confidence to try!"

Beginning in December, teaching artist Melanie Rick will present workshops titled *The Power of Pictures, Reading Art Across the Curriculum.* These workshops will integrate visual art and ELA learning objectives in a powerful approach that can apply not just to art, but to looking at the world.

"Chautauqua Institution is proud to partner with schools to bring these opportunities to Chautauqua County teachers," said Chautauqua Institution Kennedy Center Partners in Education Program Manager, Lisa Gierszal. "With so many new challenges, we felt it was even more important to support teachers as they work to best serve our county's children."

### **Returning to School During COVID-19**

To help maintain a healthy school environment, it is important to keep your child home if they present with any COVID-19 like symptoms. For a full list of symptoms and information, please review the symptom list on the school website, www.clake.org, under the Reopening 2020 heading. It is also important to complete the daily health screening form, which can be found on the CLCS website under Reopening 2020 on the school website.

According to the Department of Health, if you keep your child home sick or they are sent home from school, the following things need to happen before they can return to school:

- •Call your primary care physician (PCP).
- If determined by your PCP that the child has a diagnosis other than COVID-19, the Health Office needs written documentation from the PCP of the diagnosis and when the student may return to school. The documentation must be received in the Health Office before they may ride the bus or enter the building. The Health Office fax number is (716) 753-2085.
- If your PCP recommends COVID-19 testing, get your child tested. The child may return to school when a negative COVID-19 test result is received and the child feels better and has been fever free for 72 hours without the use of fever reducing medicine.
- •If no COVID-19 test is done, your child needs to stay home for 10 days since the first symptom began and has not had a fever for 72 hours, without the use of fever reducing medicine, and is feeling better.

## **Cold Weather Tips**

In anticipation of cold temperatures, please be sure that your child is dressed appropriately. Layering clothing is the best (coat, jacket, sweatshirt, or sweater), plus head and hand coverings. Please do not allow your child to leave the house with exposed skin (ears, hands, legs, etc.) as this increases the chance of frostbite in cold weather. If your child needs warm clothing (coats, hats, or mittens) and you cannot provide it, please call the school nurse at (716) 753-5819 for assistance.

The Chautauqua Lake Safety Committee offers the following tips for avoiding slips and falls during the Winter season:

- •Select appropriate footwear
- •Give yourself extra time for travel
- •Be careful walking on slippery surfaces
- •Wipe your feet when entering a building
- •Seek help if you fall and injure yourself Immediately see the School Nurse and report your incident.

You are encouraged to report slippery conditions in the District's parking lots, walkways, and building entrances to the Buildings & Grounds Office at (716) 753-5825 or any school office.


## **Social Distancing Practice**

## Investing in our Students, our School, and our Community

On December 15, 2020, residents of the Chautauqua Lake Central School District will have an opportunity to vote on a proposed Capital Construction Project. This project is intended to enhance academic opportunities, prioritize health and safety and enable our district to be a community resource for years to come.

The New York State Education Department requires a needs assessment every five years to be sure districts are planning for and maintaining assets. This Capital Construction Project proposition was designed to meet the needs of the 5-year facility plan.

Our Board of Education and Capital Project Committee members were extensively involved throughout the planning process. The committee initially identified more than \$22 million in potential facility, safety, and educational needs. After further review and consideration of the financial impact of the proposed project, the committee recommended a smaller Capital Construction Project. The proposed plan is designed to maximize available New York State aid and not seek an increase in school property taxes to pay for the project. The project addresses the needs and objectives set by the Board of Education, while leaving an energy efficient footprint. If successful, the 2020 Capital Construction Project would bring \$18,550,000 in extensive improvements to the Chautauqua Lake Central Schools campus.

## THE DISTRICT ANTICIPATES **NO ADDITIONAL PROPERTY TAX** INCREASE RELATED TO THE PROPOSED PROJECT

The proposed upgrades are districtwide with a focus on critically important building systems, computer and technology infrastructure, cafeteria enhancements, STEM program expansion, and athletic and site improvements. District residents are encouraged to exercise their right to vote Tuesday, December 15, 2020, from 7 a.m. to 7 p.m. at the bus garage.

### This project is designed to address 3 key areas:

- Preservation of district investment in facilities, buildings and grounds
- Increased health and safety infrastructure throughout the district
- Enhanced student programming and learning experiences

Capital Construction Projects like this one help to keep our facilities in good working order and improve the conditions under which our children learn. Through careful financial and educational planning, we are confident that we will continue to be one of the region's top school districts.

## **FREQUENTLY ASKED QUESTIONS**

## Q. Why is the district having a Capital Construction Vote?

A. The Chautaugua Lake Central School District is committed to providing well maintained facilities and a safe learning environment for students and public use. Most of the work included in this proposed Capital Construction Project is "planned maintenance." Routine facility maintenance and repair work is typically funded in the annual District budget, with local taxpayers bearing the full cost. However, sizable renovations, repairs and replacement of "end of useful life" items such as those included in this project, would have a MAJOR IMPACT on the tax levy if included in the annual district budget. Therefore, the district has designed this project to utilize NYS aid that can be used only for such projects.



Playground Reconstruction A new rubberized safety surface at the playground will not only enhance safety, but will also eliminate the need to keep filling divots and low spots with mulch annually. Also, the new equipment would be fully ADA complaint and age appropriate.



## ABSENTEE BALLOTS

The Chautauqua Lake Central School District located at 100 Noth Erie Street, Mayville, NY 14757 is required by law to have absentee ballots for the December 15, 2020, vote. Applications for absentee ballots for voting on the 2020 Capital Construction Project may be applied for at the office of the School District Clerk.

Any such application must be received by the District Clerk (i) at least seven (7) days before the date of the vote, if the ballot is to be mailed to the voter, or (ii) the day before such vote, if the ballot is to be picked up personally by the voter.

Absentee ballots must be received in the office of the School District Clerk no later than 7 p.m. on December 15, 2020. All questions regarding absentee ballots may be directed to the: District office at (716) 753–5808.



## **FREQUENTLY ASKED QUESTIONS ...**

## **Q**. What is the total cost of the proposed project?

**A.** The total cost is \$18,550,000.

### Q. How will it affect my taxes?

**A.** The project is designed with the intent that it will NOT cause an increase in district property taxes. State building aid and district reserves will fund the project. The current 2020-2021 State Aid Building Ratio for Chautauqua Lake is 72.1%. Working closely with our financial advisors, past and present boards of education have allocated funds for this project, therefore, we expect that this Capital Construction Project will NOT alter our annual budget.



#### Technology Improvements: The existing clocks would be replaced with new I.P. clocks and speakers. (Above) This new technology will have the ability to broadcast messages for safety and help enforce security procedures and protocols.

## **Q**. How were the project's components selected?

A. Every 5 years, all school districts in New York are required to have a registered architect review the condition of their buildings and grounds. In 2015, our architectural consultant performed a Building Condition Survey that examined the district's facilities and identified problem areas requiring repair or replacement. A district subcommittee comprising of administrators, teachers, Board of Education members and support staff - studied the survey items and developed a prioritized list of repairs and upgrades. The district is addressing those issues now rather than delaying and facing future higher costs and further deterioration. Building Condition Survey items, academic program enhancements and safety concerns received top priority, as did code compliance and mechanical items.

### Pool Dehumidification System:

The Dektron unit, that regulates the humidity in the pool is 20 years old and is a challenge for the district to keep running. It would be replaced as a part of this project.



#### Q. When will the work begin?

**A.** If a "YES" vote occurs, the design process will begin. Once the design and construction documents are completed, they are submitted to the New York State Education Department for review and approval. The project would be done in two phases.

Phase I which is a critical maintenance phase, would be submitted to the State Education Department in spring of 2021 with construction during the remainder of 2021.

Phase II, a larger phase, would be submitted to the State Education Department for review in the Fall of 2021, and construction would start in summer of 2022.



#### **HVAC EQUIPMENT:**

The major air handling units that serve the building are now all 20 years old and at the end of their useful life would be replaced in this project.

## HIGHLIGHTS OF THE PROPOSED 2020 CAPITAL CONSTRUCTION PROJECT




Main Loop Heat Pump Replacements: There are several main loop pumps that are critical to the heating and cooling of our school building. These pumps are responsible for pumping water to and from the geothermal well fields, back to the building, and then throughout the building. This year one of the pumps experienced a critical failure. (shown above). This is evidence that these pumps are at the end of their useful lives. These pumps would be replaced as a part of this project. \* \* \* \*



SIGNAGE IMPROVEMENTS: As Part of the project the main entrance sign (above) would receive a full reconstruction, along with additional signs being added campus-wide.



### KITCHEN EQUIPMENT: Currently our kitchen equipment is 20 years old and limits the menu options for our students at CLCS, space is tight both in the kitchen and in the actual cafeteria. In the interest of increased participation, we're looking at different space and serving line opportunities along with the replacement of all of the equipment as a part of the proposed referendum.



Athletic Field Lighting: As part of the project the athletic field lighting would be converted to LED, extending longevity and generating an energy savings.





### Technology Infrastructure

11.4% of our students now engage in remote learning. This new dependence has shown us the importance it plays in education, and has demonstrated a strong need for us to bolster this infrastructure. #### Window System Replacements

Over the past few years several windows have started reaching the end of their useful life. The maintenance crews at CLCS have remained vigilant in maintaining our windows and repairing them as needed. As more of these windows require the attention of our maintenance staff, it has become more evident that a building-wide replacement of these systems is needed. If approved, windows would be replaced on wide scale as a part of this capital project.



#### **Geothermal Well Vault: Valve Replacement**

The valves located in the geothermal well vault have been subject to extensive water damage and in order for the valves to remain functional they need to be replaced. These valves would all be replaced and measures would be taken to mitigate any water coming into the underground vault.
